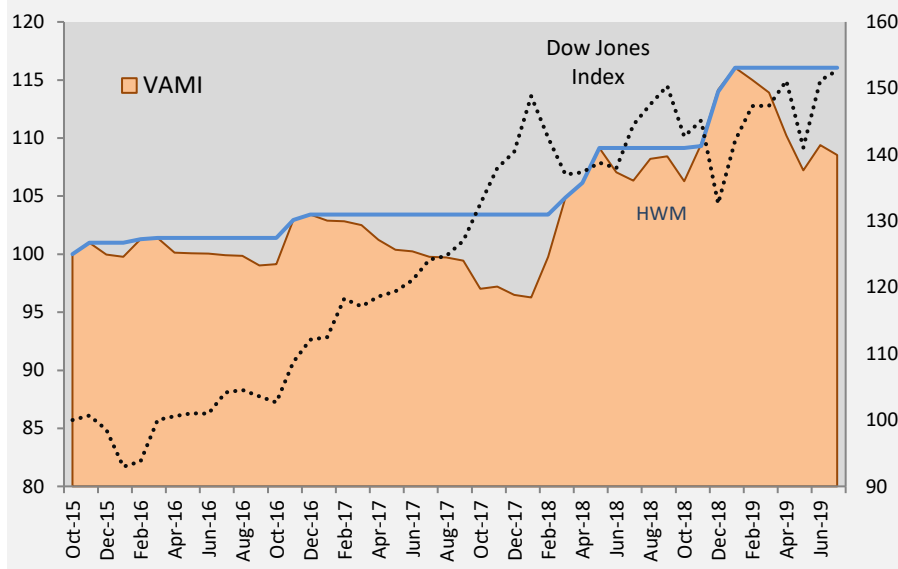

Designed as institutional version of DH Nix Program, with a customized Money Management algorithm.

Commentary

Toppish market and low intraday volatility that characterized the month of July resulted in a small loss for NixAlpha, that was able to limit damage in a market environment not favourable for its strategies. The continuous improvement of team procedure and fine tuning of IT allowed to drastically reduce the residual slippage of the system. Drawdown is within our expectation and both from a magnitude and duration point of view.
